On 11-10-82 at 11:45 A.M., officers were able to talk to a JIMMY DON LEWIS, who has Waco PD #27601. Officers were able to make contact with JIMMY DON LEWIS, with the assistance of West Police Chief JERRY HUGO, who obtained the address of Route 1, Box 50, West, Texas. In talking to JIMMY DON LEWIS, he stated to us that he had been in the NAVY in San Diego from March 2nd '32, until May 13th of '82, when he was discharged. However, he has stayed around the San Diego area until June 10th of '82, and then came home to his grandfather's house in West. He did state also, that he had been to the 7-ELEVEN STORE at Cobbs and Lake Air, where the name had come up to us, in reference to him having a knife attached to his belt.

Sgt. BAIER and I did check the brass knife, which had been described by TRUETT JOHNSON on 07-19-82. This knife did have the words ISTAMBUL inscribed on the handle. However, the whole knife was approximately 4" in length, and it appeared to be the souvenir type knife, more than a cutting knife itself. The 4" in length is including the handle also on it, which could possibly be used as a letter opener more than anything else, being that the blade was not sharp at all, and that it was made from brass.

On 11-12-82, I contacted several kids who were enrolled in Summer School at UNIVERSTIY HIGH SCHOOL in July, the same time that KEN FRANKS was going to Summer School. I did talk to a KIM MCKAY, WF, age 17, of 6814 Edmond, phone 772-9209, who is attending RICHFIELD HIGH SCHOOL at this time. In questioning her about the conversation of comments being made on a certain girl being told about the bodies at SPEEGLEVILLE PARK, prior to it being on the news. She stated that she did not remember hearing any conversation of such nature, nor does she remember whether LISA HOGELAND, who had been involved in this rumor, was there in the group at the same time. I did also contact a BRIAN GOODING, WM, age 17 of Mart, Texas, phone 876-2348. Also, a DANNY HALL, WM, 16, of 1208 E. Texas Avenue in Mart, phone 876-3260. Neither one of these two above mentioned subjects remember the conversation which had been brought to our attention early, after the murders. This information had been obtained from a known informant, whose name was not placed in our report.

On 11-15-82 at 4:50 P.M., I did talk to a RUBY SHAVER, concerning her boyfriend, ROY QUINONE. She lives at 3101 James, who has PD#29384 with our Department, hispanic male, DOB: 09-21-62. Informant advised us, that ROY QUINONES had made threats to Ms. SHAVERS, and had said, "That he was going to kill Ms. SHAVERS, like he had cut the kids at the lake." (CONTINUED)

In talking to RUBY personally, she stated that she felt like this statement had been made to her by ROY. However, she said she took it as a joke, and not as the truth, being that she and ROY left to go to Fort Wayne, Indiana on her birthday, July 11th of '82, and that she had returned approximately two to three weeks later, with ROY staying in Fort Wayne, Indiana, as he was trying to get into the ARMED FORCES, possibly the NAVY. RUBY stated that ROY was now in Florida, enrolled in the Navy. RUBY is staying with an IRANIAN at the Sherman Forest Apartments in Northcrest, phone 799-8709. She could be contacted at her mother's house, 3016 Mildred, 755-7228.

Also recontacted DEANNA STORST, white female, DOB: 06-15-65, of 808 Rambler, Apt. #7, on 11-17-82 at 1:05 P.M. Arrangements were made for Ms. STORST to come to the Police Department on 11-19-82, for an interview.

The interview was conducted at 9:00 A.M., 11-19-82 with DEANNA STORST, where she related that she and her boyfriend, RICKY PATE, were parked at KOEHNE PARK entrance from about 7:00 P.M. until 11:00 P.M., or so. She stated that about 9:00 P.M., she had seen an orange Pinto come to the park. However, she said that she did not pay much attention to the occupants. However, after the car had gone down to the beach area, and had come back up about five or ten minutes later, she noticed that the passenger on the right front was KEN FRANKS, who she had known before, from him going with a friend of her's, that lives in the same apartment on Rambler.

DEANNA stated that she had seen a blond headed girl sitting on the rear passenger side, but was not able to see who the driver was. She stated that this vehicle traveled to the boat landing area, which is to the right of where they were parked, and she did not remember seeing the vehicle come back up toward Valley Mills Drive, or Lake Shore Drive anymore that night.

She did state that she did remember seeing a new maroon vehicle, with a sun-roof, and a white subject approximately 30 to 40 years of age, with a brown English cap and glasses. The vehicle was described as having a sun-roof, which was open, and had the music blaring. She stated that this vehicle, which was a maroon Lincoln, came to the park several times, would go down to the boat ramp, and would come back out and go toward Valley Mills Drive where the drag

is, and would come back fifteen to twenty five minutes later. She remembered that the subject would just come by, make the turn and go back out. She then remembered that she had noticed subject in the maroon vehicle with this older gentleman, who appeared to be KEN FRANKS. She stated that this happened approximately thirty to forty five minutes after she had seen the ...to going down to the boat ramp, and after she had seen the subject and KEN FRANKS leave in maroon car, she saw the car return approximately forty five minutes later, which would make i around 9:45 or 10:00 P.M., without the young subject, who she thought was KEN FRANKS. She sai after this, they had left, and did not remember anything else, other than that.

She stated that she had called the Police Department to refer this information to the CRIME-STOPPERS. However, she did not have a license number available for the car. Therefore, she had called back again three weeks after she had called in the first time, which would have mad it about the third or fourth week from July 13th, and furnished a license number, being ZGZ721 which came back registered to a 1980 Lincoln 4D, to a ROBERT E. FRUEH of 2934 Savannah Court.

DEANNA described the subject as wearing glasses, the brown English cap and possibly a receding hairline. She feels like she could recognize this subject again. I did show her a PD picture of ROBERT FRUEH, which is PD#26151. She stated that this subject was very similar to the subject that she had seen at the park that night, being as he had come in several times to the park.

After this information was obtained, it was very important to this case to find out for sure, if the young subject DEANNA STORST had seen in the car was KEN FRANKS, and very vital information as to where she had seen the subject in the car, prior to, or after seeing the orange Pin in the park. Therefore, a hypnosis session was set for 11-20-82 at 5:00 P.M., to be conducted by Detective BOBBY LUEDKE of the Waco Police Department.

11-20-82, at 5:00 P.M., the hypnosis session was conducted, which was also conducted and pscribed on tape, where DEANNA STORST related the same facts, as stated the day before, und. hypnosis to Detective BOBBY LUEDKE. She described the car in detail, and also being positive that she had seen KEN FRANKS in the maroon car with the subject in the maroon car, bearing

ZGZ721, which is registered to ROBERT FRUEH of 2934 Savannah Court.

On 11-22-82 at approximately 7:30 P.M., myself and Detective Sgt. BAIER did go to 2934 Savannah Court, where we made contact with Reverend ROBERT FRUEH, who is also employed at FOUR-C COLLEGE in reference to his whereabouts on July 13th of '82. Reverend FRUEH did advise that he had been to the park, being KOEHNE PARK, at approximately 1:00 to 1:30 A.M., 7-14-82, and had made contact with two subjects and two girls, in a pickup at the O-6 landing, and he had inquired about a girl in a gold Chevelle, who he was supposed to meet there after she had gotten off work. However, this did not coincide with information that we had received earlier, of Mr. FRUEH giving a name and a phone number to another subject, which was in a different car aside from the one he was describing at this time. Therefore, after this conversation was about to be concluded, we did ask, and offered Mr. ROBERT FRUEH a polygraph as to his whereabouts, to verify that he was telling us the truth about his involvement of this incident on July 13th of '82, at the early morning of July 14th of '82.

Mr. Reverend ROBERT FRUEH was advised to consider the matter for a few days, and to call us back about what he decided to do. As of this date, he has not called. Therefore, I did call ROBERT FRUEH at his place of employment at FOUR-C COLLEGE, where he advised me that he had made contact with an attorney, by the name of LOU BRIGHT of 755-0380, and for me to contact him and explain to him the circumstances, and the procedures for the polygraph, and that it would be up to his attorney, to advise him if he was to take it or not, after I advised him what I really wanted on the polygraph. I did contact the attorney, LOU BRIGHT. However, he did not return my call as of this report being made.

On 11-19-82, at 12:15 P.M., I did talk to a JOHN HENDERSON, who had been interviewed prior on him being at KOEHNE PARK on July 13th of '82, at approximately 7:00 P.M., and had seen KEN FRANKS and the girls at O-6 Landing. However, this contact was in reference to KEN FRANKS and the girls being seen getting into a bright TRANS AM or Z28, on the night of 07-12-82. At this time JOHN HENDERSON advised that he had not been at KOEHNE PARK that night. However, he did not know KEN FRANKS from previous contacts, and also through some of his acquaintances. He did not know the girls at all.

On 11-23-82, Sgt. BAIER and myself did go to Waxahachie, Texas, where we were to interview some people who had not been contacted before, in reference to this case. At 6:45 P.M., 11-23-82, I did make contact with DAVID LATHAM of 535 Golden Meadows, Duncanville, Texas, phone 298-2933. This subject was the last boyfriend of RAYLENE RICE. We could not obtain any useful information from this subject, whatsoever.

At 1:15 P.M., 11-24-82, we did talk to RAYLENE RICE's sister, RENELLE. She stated to us that she had been with RAYLENE and a friend of her's on Monday night, 07-12-82, and they had been over to DAVID LATHAM's apartment in Duncanville. She had also been at her home at 12:00 P.M., 07-13-82, when the girls had left, and she knew that they were going to Waco, but she did not know what they were going to do when they got there, that she was supposed to be home 10:00 P.M. that night. That was what she had told her mother, that she was going with JILL and her mother to eat, and would be back before 10:00 P.M. She did state also, that they were in Waxahachie at the SAFEWAY PARKING LOT, until about 10:30 or 11:00 at night, when she was taken home by her sister, RAYLENE.

In questioning RANELLE about JILL's involvement, and her knowledge of JILL, she stated that JILL was taking three to four hits of speed a day, and that she had lost quite a bit of weight in the last few months before her death. That she was using black mollies and other kinds of speed. She also said that JILL had been going with a mexican subject, who might possibly be from the Methodist Home. However, she does not remember what name that she had given her. If and when she thinks of the subject's name, she will be calling us with this information. She also did not know where, or who JILL was obtaining her drugs from. However, that she did know that JILL was very heavy into the drug scene. This is all the information that she could give us about JILL, and her sister.

We did make contact with two other girls, being a GLORIA DEE HOPGOOD of 413 Williams in Duncanville. Also, a LAURIE HOPGOOD, who are sisters, who had been asked by JILL if they wanted to come to Waco with herself and RAYLENE. However, they had work to do, and GLORIA DEE having other things to do with RAYLENE's sister, RANELLE, was the reason she refused to come. Neither of these girls were able to tell us the reason, or anything about the trip to Waco by

both of these girls, RAYLENE and JILL, other than to come pick up their check and go back to Waxahachie.

11-29-82 at 2:30 P.M., I made contact with a DANA MILLER of 300 Cottonwood, Apt. #807, phone 0967. This name had been found by a Mrs. SHAW, JILL MONTGOMERY's mother, in JILL's belongings. In contacting DANA MILLER, she stated that she knew JILL MONTGOMERY from the Big Sister Program that is being conducted at BAYLOR, and that she would take JILL and act like a big sister to her, and take her to church services on Sunday. She stated that JILL did not really confide too much to her, in telling her some of her problems and such as that. However, she was able to give me the name of JILL's roommate, being ANGIE RHODEN, white female, approximately 15 or 16, whose name we had not obtained before. I did ask Ms. MILLER if she thought of anything other than what she had told me at this time, to contact us back again with the further information.

At approximately 3:00 P.M., 11-29-82, I made contact with the METHODIST HOME, and made contact with Ms. MARY BILHEMIER, and made arrangements for ANGIE RHODEN to be brought to the Police Department for an interview.

At 4:30 P.M., 11-29-82, an interview was conducted with MICKI ANGELA RHODEN, DOB: 02-04-67. ANGIE stated that she had been at the HOME since June 5th of '78, and had been at the MAYME MITCHELL UNIT, 753-0181, Ext. 430. She stated that she had been placed with JILL as a roommate in the early part of '82, being possibly around February. She said they did get along real well, and that a few weeks or a month after them being placed together as roommates, that JILL had introduced her into drugs, mostly being marihuana and eating speed. Then later, when she had to quit the drug scene, that she and JILL had just about gotten away from each other, and that JILL's best friend then, was a GINGER YOBY, who has been interviewed before. However, next contact will be made with GINGER YOBY for further information on JILL MONTGOMERY. ANGIE RHODEN stated that she will be leaving the HOME December 17th of '82, and will be going to Baton Rouge, with her mother, SHARON LANDRUM of 225 Steering Lane, area code 504 665-4010.

Also, in talking with Ms. BILHEMIER, she stated that the mother, being a Ms. PATSY LYLES, Ext. 430, could possibly give us some information into the activities conducted by JILL MONTGOMERY at that Unit. Therefore, arrangements were made for 9:15 A.M., 11-30-82, for an interview with Ms. LYLES. The interview was conducted, where she advised us that sometime a few weeks after the murders, that her husband, Mr. LYLES, had been at the putt putt at LION'S PARK, and had been told by the subject working the office there, that he had seen the kids, being KEN FRANKS, JILL and RAYLENE, the afternoon of the murders. That they had come to play putt putt, and after arriving, they had decided not to play, and had made a big deal about getting their money back. This is the reason she remembers them, and that the dark haired girl was doing all the talking, referred to the man as her coming from Waxahachie, and that they did not have any putt putt in Waxahachie. Therefore, she wanted her money back, instead of having a ticket to be used later. However, she did not know the name of the subject at this place. Arrangements will be made to make contact with this subject, for further information on this.

In asking Mrs. LYLES if she knew of any boyfriend that JILL might have had by the name of ROBERT, she stated that she did not know of any ROBERT that she was going with, that might have been of Mexican descent. However, she remembers two ROBERT's that had been causing problems at the HOME, and one ROBERT had gotten one of the girls in trouble, by getting her pregnant. This was a ROBERT TORRES, who lives near 29th & Lyle. This subject does have a police record with our Department. Also, a ROBERT MENCHACA, HM, about 20 years of age, who lives near 19th & Pine who they had also had trouble with approximately a year or two ago, when he was concealing runaways from the HOME. A picture of ROBERT MENCHACA was shown to ANGIE RHODEN to see if she remembered seeing this subject maybe going out with JILL. However, she did not remember ever seeing the subject before.
