He did not know where they had gone after that. He told me that it is very unlike his daughter not to call him as she has spent the night away from home before, but she usually calls him and this is very like her. I did tell him that we were picking the vehicle up and it would be in our custody.

7-14-82, at 3:10P, I recontacted RICHARD FRANKS, 2804 Savannah Court, ph/776-4820, bus. ph/776-4820. He told me that he still had not heard from his son. If he heard anything at all he would recontact the Police Department. I told him that we would be working on the case.

When I talked to NANCY SHAW, she told me that she would be coming to Waco on 7-15-82, and that she would bring a picture of RALENE RICE and JILL MONTGOMERY.
