On 7-22-82, at 1:53P, CANDYCE SATTERWHITE, 772-1300, came to the detective office where aft signing a hypnosis consent form, and also check list for the investigating hypnosis session was filled out, CANDYCE underwent a hypnosis session.

OFFICER WAYNE HOSKINS was a witness to the hypnosis session, and CANDYCE revealed additional information. She stated that she and DAVID PARCY, her boyfriend, had gone to Skaggs at approximately 9:45P, on 7-13-82, and at approximately 10P, same date, they had gone to the Target. However, it was closed. After leaving Target they rode around on Valley Mills Drive and the proceeded down Valley Mills Drive to Koehne Park. She stated that DAVID was driving the car turned left into Koehne Park and then turned left again, and went around the curve and pull up and stopped, headed pointing toward the lake. She stated that he parked there, they were talking and that she observed an orange Pinto on the right side of the vehicle, passenger side and on the left hand side was a white pickup with a rack on it, possibly a GMC, had a rack with wire mesh in the back window and hanging inside the pickup was a shirt on the back glass. On the right passenger door was a red magnetic sticker, with a white border, approximately 1/2 inch or inch and a half around the side, that was white in color. She stated that the sign had the following letters; "CHAS. RO or RA" She stated that Body Shop came to her mind. However she does not remember actually seeing body shop actually written on the sign.

She said that it had two headlights, square. However, the lights themselves were round. She stated that the sign was approximately 1 1/2 to 2 feet square, and was the magnetic type.

She also advised that she had seen a white female with a purple and gray halter top, and blue jeans or dark pants, blond hair, possibly bleach blond, standing behind the vehicle, appear to have been walking from the direction of the truck, directly behind the orange Pinto. However she did not observe where she came from or where she went, after she observed her. Stated that the female was approximately 130-140 lbs, appeared to be fat or heavy, and maybe 5'6", 5'5" However, she could not get a very good description of her.

She again talked about the truck and said that it was a white pickup, and appeared to be dirty and heavily scratched on the sides where the bed was, and appeared to be larger than regular sized pickups, and was built like a pickup truck. A tape was made of the session if needed for further information. DET.SALINAS, LT HORTON were advised of the results of the hypnosis session and the case investigative check list and the consent form will be turned in to Records and attached to the case.
