On 7-26-82, Monday, at 10:A, I contacted a Subject by the name of JOEY SCOTT, W/M, 16YQA, who lives at 2020 Primrose Apt. #283, no telephone. This Subject's mother, JULIE SCOTT, had told OFF. GEORGE MARKHAM that her son JOEY had talked to a young female named MICHELLE SHILLINGS who is the girlfriend of KENNETH FRANKS and she advised MARKHAM that I needed to talk to her son. Upon my arrival I contacted both she and her son, they were at home at 2020 Primrose. He told me that MICHELLE SHILLINGS had told him that she had talked to KENNETH FRANKS around 11:00/11:30P on Tuesday night, the day on which KENNETH FRANKS was killed. He further told me that he thought he saw KENNETH FRANKS at the apartment complex at 810 Rambler on Tuesday the day of the murder at around noon but that he was not sure that this was KENNETH FRANKS. That he was riding a red Kawasaki at that time. At 8:55A on 7-26-82, I contacted Subject JOHN ASHLEY, who lives at 2525 Glendale, 756-1591, W/M, 17yoa, and he stated that the last time he had seen KENNETH FRANKS was on Wednesday, a week before he was found. He stated that he knew that KENNETH FRANKS had smoked a few joints, that he had gone to summer school with him and that he thought most of the time that he had scored from a black Subject but he did not know this Subject's name or would not reveal it. JOHN ASHLEY goes to RICHFIELD HIGH SCHOOL and stated that he did not run around with this group but only knew him as an acquaintance. At 10:50A, 7-26-82, I contacted MICHELLE RENEE SHILLINGS, W/F, 13/8-6-68. She lives at 810 Rambler Apt. #5, phone 772-3425, her babysitting job telephone number is 772-5388. She babysits at 808 Rambler Apt. #2. Upon talking to MICHELLE she related to me that she had talked to KENNETH FRANKS at 8:30P on Tuesday, 7-13-82 and they had talked to approx. 8/8:15P on this date. She stated they just discussed different things. He wanted to let her listen to some of the music that he had just taped and was explaining to her about the new speakers that he had gotten for his stereo. She stated nothing important. She further told me that KENNETH FRANKS was supposed to have a date with her on this date, Tuesday the 13th, however the reason that he had phoned was to cancel the date that he had some friends coming in from out of town, that he would not be able to come over. He told her that he would see her on Wednesday, July 14th in the p.m. as soon as he got through taking care of some other problems during the day. She stated the last time she saw him alive was on Sunday, July 11 at 7:P, that he came by for a couple hours and they rode around the parking lot on his motorcycle. She stated that some of his associates and best friends were PAT TORRES & DONNIE CULP & BOBBY BRIM. She stated also that KEN FRANKS did smoke

cigarettes, that he smoked Marlboro 100's. This would account for the cigarette butts in the ashtray of the orange Pinto found at Koehne Park. On 7-26-82, at 1:40P, I talked with a TAMMY BODIE, who lives at 1922 Reuter, W/F, 16yoa, and TAMMY was not at home when I called at 1:40 however she did call me back at 2:15P. TAMMY related to me that she had talked to him on the phone and that he advised her that he was going to come to her party on the 16th, her "Sweet 16" party, this would have been Friday, July 16th, and this was on Tuesday that she had talked to him. She stated that she did not remember what time but that it was around noon somewhere in the early part of the afternoon. Upon asking her about the associates of KEN, she gave me KELLY, BOBBY, DONNIE CULP, PAT TORRES, GAIL KELLY MICHELLE LEWIS AND A JOHN DANIELS, and all of these Subjects apparently are school friends of KEN FRANKS and went to school with him. She stated that she was not that close a friend and that her sister did not know KEN FRANKS at all. Her sister was throwing the party for her. Her sister being a JANET BROOKS who's name was on one of the cards found in KEN FRANKS' room. JANET does not know him at all, she was simply inviting him as a friend of TAMMY'S and TAMMY knew him through Summer School. At 8:35A, 7-26-82, I tried to contact NATHANIEL DALE BUTLER, W/M, who works at Plantation Foods, 799-6211, Ext. 226, they told me that he did not come to work until 4:30/5:P. At 5:15P on 7-26-82, I was able to get in touch with NATHAN BUTLER. He related to me the following story. That on Tuesday night or early Wednesday morning, approx. 4:30/5:A (this would have made it early Wednesday morning) he was on the other side of Robinson near Rosenthal heading to his house. He stated that he came upon a black male, 35/40yoa, 6-01, large build, that was hitchhiking going south on Highway 77. He stated he pulled over and picked this Subject up to give him a ride and told him that he was only going as far as Rosebud, that he would give him a ride that far. Once they were in the car, the black male told him that his name was WILLIAM. He further went on to state that he had been out at Speegleville Park around the lake and MR. BUTLER stated that he had noticed the left pants leg of the black male had what appeared to be quite a bit of blood splattered all over the left pants leg. He was wearing a dark shirt that was some type of plaid and long sleeves. He believed it to be blue and red or black and red, a dark colored plaid. He had on faded blue jeans. He also stated it was obvious that the black male had been drinking, that you could smell it and that he was kind of staggering when he got into the car. He further

stated that he felt like he could recognize this Subject should he see him again. The Subject had approximately 1/8 inch long beard wearing no glasses, no watch or rings that he could remember. He stated when he pulled in to Rosebud, that he pulled over and told the Subject that was as far as he was going. The Subject got out and headed south on 77. Subject told him that he was enroute to Caldwell, Texas, that he lived there and he was going to hitchhike home. He stated that this Subject kept putting his right hand down into his sock or boots, he was not sure if he had on boots or if he was just messing with his sock on the right hand side as if trying to indicate that he may be trying to hide or keep something from him. MR. BUTLER, as I stated, has no phone in Rosebud and has to be contacted anytime we need him at Plantation Foods. On 7-27-82 I went to Rosebud and at 10: I talked to a CHARLES ALFRED RAMSEY, W/M, DOB/6-20-26, Box 278, Rte. 2, LaGrange, Tx. MR. RAMSEY related to me that on 7-13-82 that he was in Koehne Park from 4:30P until around midnight. He stated to me that he had observed the orange Pinto in the park while he was there. He stated that the orange Pinto was there when he pulled up. MR. RAMSEY seated himself at the top of the hill on one of the picnic tables and was sitting there using binoculars watching the boats and skiers on the lake. He stated that while he was there he observed 5 young blacks at one of the picnic tables closest to the point going out into the water from the circle there at Koehne Park. He stated there were two black females and three black males. He stated that he was in and out of his vehicle and that he had observed several cars coming and going until he fell asleep and he keep waking up and falling asleep during the period of time of 4:30 until midnight. He says that he knows for a fact that the car was there when he pulled in between 4:30 and 5:P on 7-13-82 on Tuesday. The Subject RAMSEY has a one ton white Chevrolet pickup with a welding unit on the back. On the side of the doors it has a white sign with red lettering which is "CHAS. A. RAMSEY CUSTOM WELDING". This is on both sides of the doors of his Chevrolet pickup bearing 82 TX NK-4651. This vehicle was identified as being at the scene sometime during the evening that the children turned up missing. He related to me that while he was there he had observed a light colored or silver car with two white males pull in and set for a while these Subjects then left and returned a little later on and set for a little while longer. He does not remember anyone getting out of the car. He went on to tell me that there was a pair of boots at one of the tables but he didn't remember which table the boots were at.

He said a dark brown van came in but he doesn't think it stopped, that it just came in and kind of turned around and left. This was the only van he could remember. He thinks the blacks were in a yellow car which was parked near the picnic table up on the hill that he was sitting at. He stated that the orange Pinto did not leave from the time he got there until the time he left at midnight and that the orange Pinto was still sitting in the same place that it had been parked when he pulled in. That it had not been moved anywhere. When asked why he was in Waco MR. RAMSEY told me that he was here to bid on a welding job somewhere around 3/3:30P that he drove out to the lake. I asked him why he drove to the lake and he stated that he liked to watch skier's and boaters and that he was going to sit there and watch them for a little while before returning to Rosebud. CHARLES RAMSEY gave me the address of LaGrange, Tx. however upon talking to ROSEBUD POLICE OFFICER TROYCE JONES at 583-7919, TROYCE related to me that CHARLES RAMSEY had told him that he had lived somewhere down on the coast and upon asking RAMSEY of this he stated that he had been in Corpus Christi for a short while prior to moving to LaGrange, Tx. I have submitted a complete check on CHARLES RAMSEY in order to get a better picture of if the Subject has been involved in any type of crime. As of yet it has not returned. Also I submitted a 10/28 on his license on his truck NK-4651. DET. SALINAS & I will be talking to this Subject a little later on this date at which time either MYSELF or OFF. SALINAS will make a Form 3 supplementary report as to in-depth questioning of MR. RAMSEY in reference to the date which he was there. I asked MR. RAMSEY if he could come to WACO PD to talk with us about this and he stated that he had an important job which he must do this date but that he would be glad to talk to us later on in the afternoon. He advised that he would come in around 6:/6:30. I told him that we would be glad to meet him in Rosebud and bring him to the PD which he finally agreed to. It is my opinion that MR. RAMSEY can shed some light on other vehicles and Subjects at Koehne Park during the period of time which he say he was there. The times that he stated that the car there and what other information we have does not coincide.
