At 2:30 PM, 7-26-82, I went to the house located across from HEB and contacted Ronald Wayne Robinson who lives at 1017 Morrow, phone number 756-5244. Robinson informed me that he and a friend of his by the name of John Kent who lives at 525 N. 9th were at Oaky Dokey Nightclub at Ley Mills and Wooded Acres on 7-13-82. He stated that they had been with a female subject that had been extremely intoxicated and that they had all left the club at 11:45 PM and drove to Kohne Park to try to sober up the girl. Robinson stated that they were in his friends car which is a 1970 blue Plymouth Duster with a white stripe down the side with Louisiana license plates, #245G748. Robinson stated that after they got down to Koehne Park and tried to revive the female subject that he and Kent both noticed the orange Pinto setting in the circle at Koehne Park. He stated that shortly after they had gotten there he saw another blue Plymouth Duster come into the parking lot and spin its tires off in the circle and leave. He stated that he did not see any other people down in Koehne Park at that time. He then informed me that a black Lincoln Continental pulled up next to Kent's car and that a white male subject who was driving the car described as having curly hair with an English pea cap, a sparse mustache and sideburns, asked Kent if he had seen a Monte Carlo with a blonde driving it. Kent informed the unknown male subject that he did not see anyone fitting that description and the subject driving the Lincoln Continental then proceeded to give Kent his home phone number and told him that whenever he and his friends wanted to party to go to his house and they would have a good time

Robinson stated that the white male subject in the Continental had stated that he was smoking marihuana and hash. Robinson described the Lincoln Continental as being a newer model black Lincoln with a t-top or sun roof on it. Robinson then informed me that the person driving the car seemed to fit the description of a person that he had known while he was going to school at Tennyson Junior High a few years ago and he stated that he believed that the subject in the Lincoln was someone that he knew by the name of Mr. Frueh. Robinson stated that he had heard Tennyson Junior High School that Mr. Frueh was a homosexual.

Robinson stated that he did not know of anything else that might possibly help us that he had that night because he too was highly intoxicated and that was all that he could remember at the evening.

Myself, Detective Salinas and Sgt. Fortune had already traced down the phone number given to

Robinson earlier which was given to him by the person in the Lincoln Continental and it was the number of Robert Frueh who lives at 2934 Savannah Court.

At 9:45 AM, 7-27-82, myself and Larry Abner went to Goldstein Migels at the Lake Air Mall and contacted Robert Gregory Lewis of 4327 Memorial Drive, no phone number. Date of birth, 6-27-54. Lewis stated that he was hunting on Sunday, 7-25-82, at approximately 3:00 PM at Veterans Park and that he had come across a bloody knife and what appeared to be a rubber. Myself and Abner took Lewis back to Veterans Park where we found a blue colored rubber, a empty package of Evening Magic Condoms, apparently where the rubber had come from, all laying next to a tree where supposedly the bloody knife was found. Lewis had all ready brought the knife home and his wife had washed the blood off the knife and then he brought the knife to the Police Department and gave it to Officer Lillard in the dispatchers office on the night of 7-26-82.

Myself and Abner looked around the entire park and I found a bottle of an unknown type substance which was used for inserting syringes into the bottle such as veterinary medicine near the river bank as well as a broken table leg. I also discovered a Coors can and a Budweiser can laying next to the scene where the rubber and the knife were found. At this time I called a special investigator to the scene and Officer Lyon came down to the Veterans Park where he took photographs of all the things that I have mentioned and he dusted the cans for fingerprints.

Myself and Officer Lyon then collected all of the evidence that we had found at the scene and Officer Lyon took them to the Property Room and tagged them as possible evidence because we were unsure at that time as to whether or not this might possibly be a crime scene related with this incident.

I then went back to the Police Department where I met with Sgt. Fortune and Detective Salinas. We looked at the knife and felt as if this was probably not the murder weapon however this knife was tagged and placed in the property room as evidence.

At 12:46 PM, 7-27-82, myself and Larry Abner went to Rt. 1, Speegleville and contacted Derwin (Pubba) Wilkins. I asked Mr. Wilkins where he was on Tuesday night, 7-13-82, and Wilkins

stated that he was at home watching on tv. He stated that he has not been to Koehne Park for a few weeks. I then asked him when was the last time that he saw Tab Harper and he informed me that he had been with Harper a couple of days before I had contacted him probably around 7-25-82. He stated that he and Harper had gone into the Steak & Eggs on North Valley Mills Drive to get breakfast at approximately 3:00 AM. Wilkins stated that he did not know any rumors about the murder and that he had no ideas as to who might have committed them. He stated that he has not been hanging around with Tab Harper lately. I then asked him if he knew a subject by the name of Keith Boatman and he stated that he did and that Boatman was Tab Harpers sister's boyfriend. Bubba Wilkins was extremely nervous while he was being questioned and he was shaking quite noticeably.

At 9:39 AM, 7-28-82, myself and Larry Abner went to Gifford Hill Company on Hwy 6 and contacted Joe Quintanilla of 2205 Bagby, phone number 756-5037. Quintanilla informed me that he had been talking to a friend of his whom he wishes to remain anonymous and that his friend knew a subject by the name of Frank who lived in Bellmead that he had been talking too. Quintanilla stated that his friend said that Frank had told him that he and four other subjects had gone to Koehne Park to try to collect some money from Kenneth Franks on 7-13-82. He stated that Kenneth Franks had owed Frank and his associates over \$3000 for dope. Quintanilla stated that Frank was unable to collect the money and that he and his four associates took Kenneth Franks and the two female subjects to Speegleville Park in their car. He stated that once they got to Speegleville Park that apparently Kenneth Franks and Frank got into a fight and that Kenneth Franks started beating up on Frank. It was at this time that Frank pulled out a knife and killed Kenneth Franks. Quintanilla stated that apparently the other four subjects who were with Frank took the two female girls and abused them sexually and killed them also. Quintanilla stated that this was all the information that he knew of and that his friend was very scared and would not give him much information. Quintanilla stated however that he was going to get ahold of his friend and try to get him to come to the Police Department with the information that he knew and if he could not get his friend to come to the Police Department that he would try to get all of the information and bring it to the Police Department himself. I gave Quintanilla my business card in which contact me in case he was to find out some information and I am waiting to hear from him at a later time. This is all the information I have at this time pertaining to this case. Case continued

at about 1:00 PM on 9-10-82 Sgt. Simons and I talked with Bobby Brim. He told us that he was very close friend of Kenneth Franks. He has known him since about March, 1982. He has also known Jill Montgomery since she started school at Waco High. He does not know Raylene Rice. Bobby Brim is a student at Waco High School and is currently enrolled in the distributive education program at that school.

Bobby Brim did tell us that he had partied quite frequently with Kenneth Franks. He said that they had drank beer as well as smoked marihuana together along with other other friends. Bobby Brim and Kenneth Franks along with other friends went to what is called the Circle at Koehne Park as well as the parking lot of Jack's Stereo on N. Valley Mills Drive. These two places, Jack's Stereo on N. Valley Mills and the Circle at Koehne Park was where Bobby Brim and his friends went to party or just to meet. Bobby Brim said that he and friends went to the Circle at Koehne Park and Jack's Stereo almost every night during the summer and on weekends during the school year. Sgt. Simons and I did question Bobby Brim in reference to his whereabouts on 7-13-82. Bobby Brim said that on 7-4-82 that he and Kenneth Franks went out on Lake Waco on Bobby Brim's parents boat. Bobby Brim's parents did not give him permission too and found out about the incident and grounded Bobby for a month. On 7-13-82 Bobby received a call at about 1:30 PM from Kenneth Franks. Kenneth Franks asked Bobby to come by his house at 2804 Savannah Court and pick him up so that they could meet two girls in Koehne Park. Bobby Brim told Kenneth Franks that he could not go.

I asked Bobby if he knew anything of the murders that occurred on or about 7-13-82 and if Jill Montgomery and Kenneth Franks had any enemies that he knew of. Bobby Brim knew of no one that did not like Jill Montgomery. He did say that Kenneth Franks and the person who was the corner of Rainbow Drive Inn were mad at each other. He said that he had been with Ken Franks particularly a time on N. 19th & Parklake (Seven Eleven Store), he and Kenneth Franks and "Lucky" (Muneer Deeb, co-owner of the store at 1433 Herring). Bobby Brim said that he did know Muneer Deeb because he had gone into the store at 1433 Herring and did know him as Muneer Deeb as well as Lucky. Bobby Brim did say that Ken Franks had at various times talked with Deeb and that Kenneth Franks had made fun of Deeb because of his physical problems and also would flip the bird.

Bobby Brim knew that KEN FRANKS hated DEEB but had never been within the presence of the two when
