DEANDRA GAYLE KELLY, 1400 COLLEGE DR. # 218, NO RESIDENCE PHONE, NO BUSINESS PHONE.

Sgt. BAIER & I contacted GAYLE KELLY at approx. 3:P/9-12-82 in our inquiry of her knowledge of MUNEER MOHAMAD DEEV. She told us the following that she had first met DEEV when he opened the bow store across from the Methodist Home, that DEEV would give her softdrinks, cigarettes, huana and other drugs to her and the kids that went to methodist home. GAYLE gave a written statement, detailing how she had met DEEV & some of the statements he had made concerning KEN FRANKS. This statement will be attached to this case in records. During our conversations to GAYLE, she related the following to us, that DEEV had rented an apt for her and hid her out while she was a runaway from the Methodist Home, had offered her \$500 to marry him for one month, had become very angry at her when he found KEN FRANKS in the apt. with her and gave the apt. to DAVID (CHILI) SPENCE when she had moved out. That she, GAYLE, had been with KEN FRANKS on numerous occasions when they had taunted DEEV by making both obscene jesters and yelling obscenities at him. GAYLE said that on various occasions, she had been told by KEN FRANKS that he, PAT MORRES and BOBBY BREM had harassed DEEV on Valley Mills Dr. After the killing at the lake, GAYLE apt was broken into twice, each time nothing was taken & the last time it was broken into, there was a red substance on the door, that she had first thought to be blood; however, she later found that it was either red softdrink or ketchup. Notes were also left on the door, stating "I'll be seeing you" or "Nice to have seen you", each time the word see or seen would be underlined. Approx. 2 weeks after the killing, GAYLE saw DEEV and he told her that FRANKS had gotten what he deserves. She became very upset and left. Also during the two weeks after the Murders, GAYLE stated that she and her roommate were continually harassed by several bikers from DAVID (CHILI) SPENCE's gang. She said that they would sat on the railing in front of their apt. and followed them and that on several times, they had met some of the bikers on the street and they would turn around and follow them. GAYLE also said that on one occasion, that her roommate PATTY DEIS went to the 7-11 store at 19th and Park Lake Dr. and that one of the bikers followed her inside the store, walked up to her and said, "It would be nice to live to be 18 years old wouldn't it". He then turned and left the store without making any type of purchase. This was also confirmed by PATTY DEIS. DEEV later saw GAYLE again and apologized for the statement that had made when he told her that FRANKS had gotten when he deserved. DEEV then started to hang out with GAYLE & her roommate occasionally. The burglaries and harassment by the bikers ended after this. GAYLE told of another occasion where she and DEEV were discussing the murders when he was at her house and said that she had made the comment that she hoped KEN FRANKS

had died fast so that he wouldn't have to suffer. She said that DEEV responded, "No, he suffer because he wasn't allowed to die fast, he was stabbed several times, but the first stab wounds around the outside of the heart and weren't deep enough to cause death". She said that also commented on how many times each person had been stabbed, saying that KEN had been bed over 20 times, JILL 17-19 and RAELYNN over 10. I checked and found out that the exact number of times each person was stabbed was made available to the public through the news Tribune on July 17th. GAYLE also stated that DET. NICOLETTI had also told her how many times each victim had been stabbed and she was sure that what she had told us was what DEEV had said, but he could have possibly gotten the numbers mixed up with what NICOLETTI had told her. During the time after the Murders, the burglaries, the notes left on the door and the harassment by the bikers, both GAYLE & PATTY continued to live in the apt. After SGT. BAIER & I had questioned them on 9-12-82 and implying that we were checking on DEEV as a possible suspect, neither of the two girls appeared to be afraid & as we were leaving, told us that they were going out with DEEV on that night. We asked that they not tell DEEV that we were inquiring about him at this time. At approx. 1:A/9-13-82, I got a phone call at my residence, the party on the other end was very excited and I could not understand her at first. I then found that it was GAYLE. Her first statement that I could understand was "He did it", I said who and she said "DEEV". I ask how she knew and she said that DEEV had told both her & PATTY that he had killed them, (KEN & the two girls). GAYLE told me that she and PATTY were at a friends house and that they were going to stay there for the rest of the night and that they would meet DENNIS & I at their apt. at 10 o'clock the next morning. The details of what GAYLE told us had occurred that night, are in her statement that was mentioned before and is attached to this case.
