Q Mr. Beckham, my name is Russell Hunt, I have some questions

A Daryl W. Beckham.

Q Okay. Mr. Beckham, my understanding is, that you are going to testify for the State, as to some alleged statements that were made to you by David Wayne Spence, is that correct?

A Yes, sir.

Q Can you tell me how many statements were allegedly made by David Spence?

A We talked about it several different times.

Q Okay. Over a period of how long?

A About a month and a half.

Q Okay.

A Or a month.

Q I'm sorry, I didn't...

A A month or a month and a half.

Q Okay. This month and a half was from what time until what time?

A About the middle of January until the last of February, or the first -- about the last of February or the first of March.

Q Of 1983?

Q And did these conversations take place in McLennan County Jail?

A Yes, sir, I did.

Q When was that conversation?

A It was in February of '83.

Q Okay. So, it was sometime during this time period that you had conversations with David Spence, is that right?

A It was after I had talked with David Spence already.

20 Q Okay. So, that, you are telling the Court that no police
21 officer told you that he was interested in any of that
22 information, is that correct?

23 A Other than what I already knew, right.

A Yes, sir.

Q Okay. And Truman didn't say anything at all to you about getting additional information?

A No, sir.

MR. HUNT: I believe that's all the questions we have, Your Honor, of this witness.

BY THE COURT:

Q So that I can understand, as I understand it, you talked to no police officer? You were in jail, right?

A Yes, sir.

Q Then, -- and during the time you were in jail, you met David Spence?

A Yes, sir.

Q Ya'll had several conversations over this period of time?

A Yes, sir.

Q At least, at some point in time, Truman Simons had you brought out? Or, I guess he had you brought out?

A Yes, sir.

Q And you talked to him?

A Yes, sir.

Q And at that time, you related conversations that you had had with David Spence?

A Yes, sir. That's correct.

Q All right. And, at that time, until you talked to Truman Simons, you had never talked to any other police officers about your knowledge of the lake -- or the purported lake murder cases, is that correct?

A Yes, sir.

2 Q Is that correct?

3 A Yes, sir. That's correct.

4 Q No one promised you anything, or told you they would do
5 anything, or made any offers whatsoever to you --

6 A No, sir.

7 Q -- is that what you're saying?

8 A They told me they couldn't do anything.

9 Q All right. When did they tell you they couldn't do
10 anything?

11 A Whenever they were doing it there, whenever he was talking
12 with me.

13 Q When Truman Simons was talking with you?
